FUTURE SPECIALTIES

As most of you know the 2014 Specialty will be held in Gettysburg, PA. I'm sure we'll be hearing more about this from the NCBCC. 2015 will be held in Olympia, WA hosted by the BCCPS, and in 2016 we will head for Boxborough, MA hosted by the BCCM. The host club and venue for 2017 will be officially accepted at the ABM in 2014. However since many places fill up quickly, it is often hard to reserve a spot even three years ahead. For this reason the board is asking our affiliate clubs to plan ahead and give some thought to hosting in 2017. We will need to return to the midwest since we will have been on both coasts. The facility at Purina Farms would be a good location, and just because it isn't in a club's backyard doesn't mean we couldn't use it. Joanne did a fabulous job from Massachusetts, and very few on her committee were anywhere near St. Louis. If no clubs come forth, certainly several people could form a committee just as Joanne did. I am pretty sure that even some folks from this year would be happy to help again. For these reasons, the board thought it wise to check to see if Purina would be available. Not surprising, they were totally booked for September and October 2017 except for one week. We have therefore tentatively reserved the week of Monday, Oct 2 - Sunday, Oct. 8, 2017. However, if an affiliate club or special committee has a different proposal, we are "all ears"!

in September. However, we are still working our way through revising and updating the guidelines, and you will be able to see any changes that are made reflected in the minutes of the monthly board meeting. Changes to all of these documents must be approved by the board, not so much to "approve" them but more to make certain that everyone is aware of amendments.

The last change that has taken place is the **format for our monthly meetings**. The meetings are now held by conference call, not by mail. The board meets at 8:30 PM ET on the fourth Tuesday of each month unless there is a conflict with the date.

When I look back at the work that your board has accomplished, all I can say is, "Wow, that was a lot"!

OBEDIENCE

While I realize that obedience can be challenging (I've never gotten past a CD.), it truly is a great foundation for a beardie. When you think of it, all the other venues involve obedience skills of some sort in their repertoire. They are that basic! Even pet beardies and their families can benefit from good manners. Our obedience chair, Laurie Lo, is working hard to make our members aware of the value of a firm obedience foundation and to create more interest in this valuable area of competition.

Part of what we have realized is that obedience is sadly lacking BCCA trophies and awards which would be a motivation for more people to participate. We have 12 conformation trophies, 6 agility trophies, 4 herding trophies, and 1 obedience trophy. Laurie will be launching a campaign to create another trophy or two for obedience. All BCCA trophies are donated by enthusiasts of the sport or in memory of a person or dog who achieved outstanding success in that area, so Laurie needs your support to create awards.
