## PRESIDENT'S MESSAGE

Another Westminster show is now in the record books, and we are well into a new year of dog show related activities.

Beardies comprise a relatively small population in many parts of the country, thus building sufficient numbers of points in area shows often requires considerable coordination. Thankfully, the wonders of Facebook, email, text messages and phone calls assist us in staying connected with our Beardie families. After conversing over the last month about Westminster, dog shows and puppy related topics, a particular subject repeatedly surfaced: the plight of the owner-handler.

The assertion is that the only way to be competitive in Bearded Collies, is to hire a professional handler, particularly in the conformation ring. This promotes the misconception that it is impossible for any owner-handler to win showing his or her own dog.

Let me address this by stating these observations are not new. These claims have existed, and have surfaced repeatedly for all the years I've been showing dogs. I voiced those concerns at various stages in my years showing in conformation. Creating a competitive edge is slow in coming and requires a multi-faceted approach by increasing one's knowledge of every aspect associated with the task. Skills are developed through repeated practice and collective experience, maintaining determination and perseverance, and most of all the right attitude. You would not compete in a marathon without having trained, or take an exam without having studied the course materials.

Though I was lucky enough to be introduced to the dog fancy early, I am a first generation dog person. I moved through the various stages of handling from fumbling with my lead and tripping over my own dog, to realizing my dog was FAR from perfect. I then apprenticed with an experienced handler, and went on to showing my own dogs, showing for other people, and advancing to handling multiple breeds. From then I advanced to multiple groups, Best in Show, and eventually nationally ranked various dogs. It took years to get to each of those levels. Each

advance brought a new set of challenges and opportunities, and in many ways each level was like starting over again. At each level I found there were, and will always be, those more talented and advanced than me, as well as those less skilled. There is no use in judging oneself harshly or giving others more value simply because they won. I gained more joy and personal growth by not focusing on whether I won or lost, but focusing on whether the experience brought enjoyment to my dog and to me. I reviewed each experience, what I learned and how it served to advance my competitive edge.

I have written previously about the need to consistently strive to learn something new. Breed knowledge is central to doing well in the conformation ring; even a diamond needs a fine cut and proper polishing to showcase its full brilliance. In addition, you need to understand and master the finer points of handling and presentation.

- Watch the professionals at work in the groups
- Ask a handler you admire, when he or she has time, to give you a few tips. A true professional is only too willing to help and share with people that are trying and truly want to learn.
- Periodically have someone film you showing your dog so you can see what the judge sees.
- Handling classes are NOT just for dog socialization; find a class or seminar given by an experienced handler.
- Read books on handling or attend a good handling seminar. My first and longtime favorite book was George Alston's, *The Winning Edge*, and I spent hours in the driveway practicing each exercise.
- Learn how to groom. Untrimmed and natural does NOT mean ungroomed. Learn to properly care for your Beardie's coat and bring them to the show clean, un-matted, and with clean ears and teeth.

**NEW BUSINESS**

1. Motion to approve the Executive Committee decision to enter into a Letter of Agreement between the Bearded Collie Club of America and BTC Enterprises to reserve specific dates for an auction item to be offered for the 2017 National Specialty passed without dissension. (Furlow). (Please note the BCCA and National Specialty host are under no legal or financial obligation under this agreement in the event the item does not meet the minimum bid.)
2. Motion to establish a Memorandum of Understanding (MOU) between the Bearded Collie Club of America (BCCA) and the Bearded Collie Club of Canada (BCCC) in which the BCCC receives one b/w page to advertise their National in the Beardie Bulletin and up to two flyers in the Bagpipes; the BCCA will receive one b/w page in the BCCC's Colleague and up to two flyers in the BCCC's electronic newsletter to advertise the BCCA National and/or affiliate club event. A finalized MOU will be signed by the acting Executive Committee of both clubs and may be nullified at any time by mutual agreement of the two clubs passed without dissension. (Prassa)
  - a. This motion was amended to read, "Motion to amend the Publications Guidelines to add under Beardie Bulletin, Advertising, "A Memorandum of Understanding (MOU) between the Bearded Collie Club of America and the Bearded Collie Club of Canada in which the BCCC will receive each year one b/w page to advertise their National Specialty in the Beardie Bulletin and up to two flyers in the Bagpipes; the BCCA will receive each year one b/w page in the BCCC's Colleague and up to two flyers in the BCCC's electronic newsletter to advertise the BCCA National Specialty and/or an affiliate club event. An MOU will be signed by the acting Presidents of both clubs and may be nullified at any time by mutual agreement of the both the BCCC and the BCCA." (Conner) The amendment passed without dissention. 3. Motion to Amend the Publications Guidelines under Judges' Complimentary Copies to strike the following: "Complimentary copies of the Beardie Bulletin shall be sent to judges at the third class postage rate upon a written request by an AKC judge." and replace it with "The publications committee will be given a yearly budget to establish an on online host for a digital edition of the Beardie Bulletin to provide approved AKC judges of Bearded Collies access at no charge. BCCA members who

are approved judges will continue to receive a mailed hard copy of the Beardie Bulletin” passed without dissention. (Prassa)

### **PRESIDENT’S MESSAGE *continued***

While observing others, asking questions and reading are key to adding to your handling skill set, there is simply no substitute to getting out there and doing. Many of us go to agility, rally, herding, etc. classes every week to learn and practice. Think of conformation shows as a monthly or quarterly class where you and your friends gather to visit and compare notes. Plus there's a chance you could win! Most handlers will tell you that most any dog can be finished; it is a combination of the law of averages and that you truly do learn the more you do, so stay diligent and persevere. I learned the most about handling, grooming, and training from dogs with decidedly less than ideal conformation. With that in mind, learn your dogs’ faults as well as their finer points. There is no perfect dog and the advantage that most handlers have, is they know the tricks of minimizing the faults while “selling” the attributes.

There is NOTHING a professional handler can do that a dedicated owner-handler willing to learn cannot also accomplish. In many ways an owner-handler has a distinct advantage over the professional. A professional handler may be responsible for overseeing the care, training, grooming, and exhibition of dozens of dogs in different rings with conflicting schedules in a given day. An owner-handler has to manage one or two. The owner-handler has more time to train and perfect any flaws, and is generally more rested than the exhausted show-weary handler. There are a countless number of highly successful owner-handlers in the sport of dogs and particularly in Beardies. Even in extremely competitive breeds like Goldens, Aussies, and Dobermans there are very successful owners-handlers in every breed lineup. The dedication and burgeoning talent of these owner-handlers is truly inspiring. In addition, the AKC is actively promoting the owner-handler with new classes offered to highlight these individuals and encourage increased participation.

I am in no way unaware of the political undercurrents and marketing that exists in the sport of purebred dogs. It is not new and exists in every other facet of our lives, from breakfast cereals to professional sports teams. Even at the top levels a dedicated owner can excel.

Every aspect of purebred dogs is focused on some competitive facet of structure or performance of the human/canine team. Competition is not inherently a bad thing. In competing we are forced to challenge ourselves and our canine teammates to improve. There is not a single instance in which we do not have the opportunity to learn and advance. Even on the worst day we leave the dog show with the BEST participation trophy in the world...the companionship, love, and devotion of our canine teammate. Really, isn't that what it is all about!?!
