MEMBERSHIP APPLICATION INSTRUCTIONS

Membership in the Bearded Collie Club of America (BCCA) is open to individuals 18 years of age or older. The application process takes approximately three months from the time we receive the completed application until the time an applicant is accepted into membership.

Types of Membership

These are the types of membership open to all persons eighteen years of age and older who subscribe to the purposes of the club and are in good standing with the AKC.

- Full Membership: Enjoys all the privileges of the club. This is available as Single or Joint (open to a husband and wife or to two persons living in the same household, who each will enjoy all the privileges of the club).
- Associate Membership: Enjoys all the privileges of the club, except the right to make motions, speak in debate, vote, and hold office. This is available as either Single or Joint. An associate membership is a good way for new members to start out, until they get to know more about bearded collies, and the BCCA.
- Foreign Membership: Open to non-U.S. residents who will enjoy all the privileges of the club except holding office and voting on the official Standard of the Bearded Collie. (This is available as either single or joint.)
- It is important to take part in BCCA activities and volunteer your time to further the club's goals, no matter the type of membership you select.

To ensure that your application is processed without delay, (1) complete the form in full (***do not leave any questions unanswered***); (2) have a BCCA member in good standing complete the sponsorship section; (3) sign and date the application; (4) read and sign the Code of Ethics (signature of all applicants is required); (5) enclose the appropriate dues; and (6) forward it to the Corresponding Secretary for processing. Please contact the BCCA Corresponding Secretary if you need help in locating BCCA members in your area to act as your sponsors.

Upon receipt, the Corresponding Secretary will submit the application to the BCCA Board for review and publication in the Bagpipes, the official newsletter of the BCCA. If no objections to the pending applicant(s) are received, a motion to accept the membership application will be voted on at the next Board meeting following publication. Upon approval, the candidate will be contacted by the Corresponding Secretary and welcomed as an official member of the BCCA.

CODE OF ETHICS

The Bearded Collie Club of America, in order to protect, preserve and promote the advancement and proper breeding and showing of the bearded collie, as well as ethical practices, does hereby set forth this Code of Ethics.

- All members shall maintain the best possible standards of health and care of their dogs and shall sell only those who are in good health and condition at the time of delivery. The breeder shall keep and pass on to the buyer accurate health, breeding and registration records at the time of the sale.
- Registration with the American Kennel Club is the responsibility of the breeder. It is recommended that all terms of agreement pertaining to sales, leasing, whelping and breeding of dogs be recorded in writing.
- Bearded collies shall not be sold to pet shops, wholesale dealers, contest sponsors or to any buyer who the breeder feels will not properly care for the dog.
- All advertising shall be of an honest and forthright nature.
- Good sportsmanship shall be advanced by members at all times.
- All members shall endeavor to help acquaint the public as to the Standard of the Breed as adopted by the Bearded Collie Club of America and approved by the American Kennel Club.
- Members shall be held responsible for instructions to handlers and groomers as to the proper grooming of the bearded collie so as to conform to the Standard of the Breed.
- Disciplinary action against any member for alleged misconduct prejudicial to the best interest of the Club or the Breed may be taken by the BCCA.
