### **Proposed Amendments to Standing Rules**

*General Discussion: The word "amendments" is used here to cover new language, consolidation of related rules, deletions, and traditional amendments. An ad hoc committee of volunteers Elsa Sell, Joanne Williamson, and Carol Freeman has been reviewing the Standing Rules in an effort to make them more user friendly, clean up outdated material, find documents referenced in, but not included in, the Standing Rules, and in general to examine how the current rules relate to actual practice. Elsa has created a Table of Contents that includes a section called "Retired Standing Rules", and an index, all of which will debut when we believe we have a fairly clean set of amended SRs. As you might imagine, this is a task that has taken, and will continue to take, much time and effort. Here are those amendments we are comfortable offering now. You will see more in the coming months. Please offer your thoughts.*

*In the following list of proposed amendments, the language of the current Standing Rule is presented in normal type, **the proposed amended SR in bold type**, and the explanation in italic type*

### **MOTION FOR A NEW SR**

03/11-06 Motion to create a standard template for motions, as follows:

Motion template: Anyone preparing a motion to submit to the Board or to the membership at the Annual Meeting, shall follow this format. "Motion to \_\_\_(here insert ALL of the material you want the Board or the membership to approve. Do not refer to documents or other material; copy the full text into the motion.) (Freeman)

*Discussion: Any motion which applies to future conduct, if passed, becomes a Standing Rule. The Standing Rule should contain all of the information that future Board members, officers, or members would need to know if reading the rule for the first time.*

Technology will change. The reference to the technology to be used should be amended to allow whatever method is currently considered reliable.*

Members without e mail receive the information in the paper mail Bagpipes.*

*Discussion: The Standing Rules are available on the website. Recent practice has been that the Recording Secretary sends updated SRs to the webmaster before the July meeting, and new and returning Board members go to that source to read the Standing Rules. It is much easier to use the search tool available on the website than to hunt "by hand" for a particular rule. The policies are not on the website. The committee is working to gather all of them and include them in the new and improved SRs.*

PROPOSAL TO AMEND SR 08/99-01

The revised Specialty Judge Nomination Forms are accepted for Regular Conformation Classes, Sweepstakes, and Futurity. All returned questionnaires will be published in the newsletter prior to any balloting. Because the forms contain a statement of agreement from judging nominees to abide by BCCA rules for judging specialties, all forms must be returned for formal consideration as a nominee. In the event that any question is not answered on the form, it will be noted that "no response" was received to that particular question. (Amended 09/01-01 and 04/04-01.)

**The amended SR would ADD the following language:**

After “question” and before (Amended...)

The following question will be deleted from the form: On a scale of one to three, rank the following in order of importance to you as a judge: \_\_\_\_ structure \_\_\_\_ temperament \_\_\_\_ coat.

The following question shall take its place:

On a scale where one represents the most important, and three represents the least important, please rank the following: \_\_\_\_ structure \_\_\_\_ temperament \_\_\_\_ coat.

Please make additional comments about these criteria here: \_\_\_\_\_. (amended 09/01-01, 04/04-01, and 03/11-16.) (Freeman)

*Discussion: If passed, the entire amended form would be included in the SR. The European nominees tend to believe that three is the highest ranking and one the lowest. The first part of the amendment is meant to clarify the rankings. This question also generates more comments by far than any other, many along the lines of “I judge the whole dog.” The line seeking additional comments is meant to allow space for those comments.*

Those SRs read:

04/88-02. Commercial Advertising.

The BCCA will allow commercial advertising (defined as including, but not limited to food products, nutritional supplements, grooming products or aids, toys, crates, beds, collars, leads, etc.) in the Beardie Bulletin at a rate of \$250.00 per full page ad and \$150.00 per half

04/88-03. Non-BCCA Member Ads.

The BCCA will accept ads from non-BCCA members at a rate double the cost of a comparable ad submitted by a BCCA member. (Amended 10/09-05: The BCCA will not accept ads from non-BCCA members.)

**The new SR would read:**

**03/11-17 Advertising**

**The BCCA will not accept ads from non-BCCA members. (Supercedes 04/88-02 and -03, restates 10/09-05.) (Freeman)**

*Discussion: The BCCA tax advisor recommended that we not accept outside advertising. On that recommendation, SR 10/09-05 was adopted. It reads:*

*10/09-05 Advertising*

*The BCCA will not accept ads from non-BCCA members.*

Postponed Agility Motions. These motions have been amended by their maker as follows:

02/11-02\_ Motion to amend SR 04/01-02 to read as follows: The "High In Jumpers With Weaves Trophy" in Honor of Mirage is established to be awarded to the Bearded Collie with the most outstanding performance in JWW in a calendar year (January 1-December 31). This trophy, featuring a metal statue of Mirage performing the weave poles on a walnut base, was proposed and financed by Beth White and designed by John Stanbridge. Each year's winner will receive a copy of the statue donated by Beth White. The base will remain in the possession of the BCCA.

To be eligible for this award, a Beardie must earn at least 6 qualifying scores of 100 (clean runs) at any level of JWW (Novice, Open or Excellent). In Novice, Open, and Excellent A, only clean runs leading to titles will be counted. In Excellent B, all legs will be counted. The following scoring system is effective as of January 1, 2010:

**Scoring:**

A Beardie will receive 5 points for each clean run and 1 point for each full second under SCT (Standard Course Time). If a tie in points should occur, the tie will be broken by calculating YPS (course length in yards/dog's time on course to 0.01 seconds) for each of the tied dogs' individual legs and the results averaged. The winner will be the Beardie with the highest average YPS. If, after this procedure is carried out, the average YPS for each of the tied dogs is the same, all will be declared the winners of that year's award. (Amended 09/01-02)

*Discussion: The major change associated with this proposed revision of the standing rule is the elimination of placement points from the scoring system. This change will remove geographic bias from the scoring system, as an evaluation of speed versus placements earned has shown that it is more difficult for Beardies of equal speed to place in JWW classes in some parts of the US than it is in others.*

02/11-03\_ Motion to amend SR 05/06-01 to read as follows: A Preferred Agility Veteran trophy is established, sponsored by Carl Widell in memory of Cagney, the first Beardie to earn Preferred Excellent agility titles. This award will go to the top veteran dog, 7 years of age or older during the entire competition year, for performance in both Standard Agility and Jumpers with Weaves. As with all the agility awards, only legs toward titles will be considered. It will be retroactive, to include those veterans who won in 2005, 2004, and 2003 (including Sept -Dec 2002).

The trophy is a rectangular plaque with a large metal plate on the left side that is laser-inscribed with the words "Bearded Collie Club of America || Preferred Agility Veteran of the Year" topped by a stop-action image of Cagney exiting the weave poles. On the right side of the plaque are metal plates for inscribing the winners' names and years.

The scoring will be based on the same sliding scale as the Denia Award:

- 100: 8
- 99: 7
- 98: 6
- 95 - 97: 5
- 93 - 94: 4



90 - 92: 3  
88 - 89: 2  
85 - 87: 1

If a tie in points occurs, the Beardie with the highest average YPS (calculated to 0.01 seconds) for all Standard + JWW legs earned will be the winner. For Standard legs,  $YPS = \text{STD course length}/(\text{time on course} - 5)$ . For JWW legs,  $YPS = \text{STD course length}/\text{time on course}$ . This change will be effective January 1, 2010.

*Discussion: The Preferred Veteran Award SR needs to be revised to include a provision for breaking ties.*

02/11-04 Motion to amend SR 05/99-03 to read as follows: Annual award plaques are established for the top Bearded Collie in each level of Jumpers With Weaves (JWW), offered in memory of Ryan (Ch Jande Hellava Knight CD HC AGI PUP), the first Beardie to obtain any type of agility title. These awards were established by Beth Canner and are sustained by an anonymous member of the Beardie agility community who will donate \$600 to the BCCA in 2011 to finance the cost of the annual award plaques for 10 years. In Novice A, Novice B, Open, and Excellent A, only legs leading to titles will be scored, no matter the year in which they were earned. In these classes, a Beardie will be eligible for a JWW award only in the year in which the title is earned. For Beardies competing in Excellent B, all legs earned during the calendar year (January 1-December 31) will be scored and there is no requirement for a title to be earned in order to be eligible for the Excellent B JWW award.

Scoring:

Novice A - Excellent A: The scores of the three legs leading to the title will be summed and the Beardie with the highest total score will be the winner. If a tie in score occurs, YPS will be calculated (to 0.01 seconds) for each of the three title legs and the results averaged. The winner will be the Beardie with the highest average YPS. If a tie remains after this procedure has been carried out, all those tied will be declared the winners of the award for that year.

$YPS = \text{course length in yards}/(\text{dog's time on course})$

Excellent B: A Beardie will earn 5 points for each leg earned during the calendar year and one point for each full second under SCT. Ties in score will be broken by the YPS procedure specified above.

These changes will be considered effective January 1, 2010. As 2010 is a transition year for these awards, any Beardie who earned a Novice A, Novice B, Open or Excellent A JWW Award in 2009, will not be eligible for the same award in 2010.

*Discussion: Previously, scoring was done by summing the number of dogs defeated when earning qualifying legs. Teams living in areas with more dogs competing in the classes or in areas with less competition in Excellent B had a decided advantage in competing for these awards as neither scores nor times were considered. In addition, there was no procedure for breaking ties. This revision corrects these deficiencies and makes score followed by time the primary considerations. The procedure of making dogs eligible for the award in the year their title is finished is also followed in*

*herding. The trophy described in the original standing rule was never given to the winners. Beth provided engraved plaques for a number of years. More recently, an anonymous donor has continued the funding for the plaques. The provision of providing a fund to pay for the award plaque will free the BCCA from any expense in continuing this club tradition for a period of ten years. If no additional donor can be found when the fund runs out, the SR can be amended to change the award to a certificate.*

02/11-05 Motion to combine SR 04/97-02 with SR 05/99-02 and to amend as follows: An annual award certificate is established for the top Bearded Collie in each level of Standard agility. In Novice A, Novice B, Open, and Excellent A, only legs leading to titles will be scored, no matter the year in which they were earned. In these levels, a Beardie will be eligible for the Standard award only in the year in which the title is earned. For Beardies competing in Excellent B, all legs earned during the calendar year (January 1-December 31) will be scored and there is no requirement for a title to be earned in order to be eligible for the Excellent B Standard award.

Scoring:

Novice A - Excellent A: The scores of the three legs leading to the title will be summed and the Beardie with the highest total score will be the winner. If a tie in score occurs, YPS will be calculated (to 0.01 seconds) for each of the three title legs and the results averaged. The winner will be the Beardie with the highest average YPS. If a tie remains after this procedure has been carried out, all those tied will be declared the winners of the award for that year.

YPS = course length in yards/(dog's time on course - 5)

Excellent B: A Beardie will earn 5 points for each leg earned during the calendar year and one point for each full second under SCT. Ties in score will be broken by the YPS procedure specified above.

These changes will be considered effective January 1, 2010. As 2010 is a transition year for these awards, any Beardie who earned a Novice A, Novice B, Open or Excellent A standard certificate in 2009, will not be eligible for the same award in 2010. Under this revised standing rule, the winner of the Novice A standard certificate will also be the Sunshine Award winner, honoring the top Novice A Beardie and handler and initially offered by the Bearded Collie Club Of Central Florida.

*Discussion: Under the previous SRs, scoring was done by summing the number of dogs defeated when earning qualifying legs. Teams living in areas with more dogs competing in the classes or in areas with less competition in Excellent B had a decided advantage in competing for these awards as neither scores nor times were considered. In addition, there was no procedure for breaking ties. This revision corrects these deficiencies and makes score followed by time, the primary considerations. The procedure of making dogs eligible for the award in the year their title is finished is also followed in herding.*

*Previously, the Novice A standard certificate and the Sunshine Award for the top Novice A team were determined by different scoring systems and often ended up going to different dogs which caused confusion. This revision will unite these two awards into one and eliminate the need for two separate standing rules.*

02/11-06 Motion to amend SR 04/01-01 to read as follows: The Diehard agility trophy is established to honor the highest scoring Bearded Collie in Excellent level agility during the calendar year (January 1–December 31). The trophy features an original Chet Jezierski color drawing of Beardies doing agility and is imbedded in acrylic and mounted on a walnut base. Plaques attached to the base allow the names of the winners to be permanently engraved. Designed by Chet Jezierski, it is offered and financed by freewill donations from the Bearded Collie agility community. Legs earned in Excellent A and B Standard and Excellent A and B Jumper's With Weaves (JWW) will be counted. To be eligible for this award, a Bearded Collie must earn at least three qualifying scores of 100 ("clean run") in Excellent Standard and JWW. The following scoring system is effective for the 2010 competition year:

Each clean run will be awarded 1 point for every full second under Standard Course Time (SCT). In addition, each QQ (Double Q = qualifying in both Standard and JWW on the same day) will be awarded an additional 10 points. Points will be totaled for each individual qualifying leg and QQ, and then added together to determine the dog's total score.

If a tie in points occurs, the Bearded Collie with the highest average YPS (calculated to 0.01 seconds) in Standard and JWW will be considered the winner.

For Standard:  $YPS = \text{Course length in yards} / (\text{Dog's time on course} - 5)$

For JWW:  $YPS = \text{Course length in yards} / \text{Dog's Time on Course}$

YPS will be calculated for each individual qualifying leg and the average value determined for Standard and JWW. These two averages will then be added and the dog having the highest YPS will be declared the winner. If, after carrying out this procedure, the dogs remained tied, both will be listed as the winners for that year.

*Discussion: With the exception of the fact that Excellent A legs will have to be hand scored (as A legs are not considered by AKC to be eligible for MACH points or QQs), these changes will make the Diehard Scoring System equivalent to that used by AKC in determining MACH point standings after July 1, 2011 when the multipliers for 1st and 2nd place MACH points will be eliminated.*

#### **10/06-01. Payment for Ad Reservations.**

All ad reservations for The Beardie Bulletin must be accompanied by the basic amount charged for that ad. Any additional costs are due within 30 days of notification of such charges.

Payment is due upon submittal of ad to Editor.

**Motions to Amend Herding Standing Rules, as follows. (All made by Freeman on behalf of the Herding Committee.) Additions are in red. The highlighted matter is explanation.**

### **04/11-04 Motion to amend SR 06/99-09, as follows:**

#### **06/99-09. Top Herding Dog(THD) of the Year. A tie breaker is added and accommodation is made for future changes in the AKC program.**

Annual awards are established for the top herding dogs of the year to be initiated at the 1994 National Specialty starting with the top dogs for the calendar year 1993. The awards are to be given to the four dogs participating in AKC licensed events that attain the highest overall average qualifying score (from all three qualifying runs in attaining the title and the top three qualifying runs in the case of the Championship Class) for each of the following classes: Started Class, Intermediate Class, Advanced Class, and Championship Class **per any appropriate AKC Regulations at the time.** This award shall be given in the year in which the title is earned, regardless of the year in which the scores were obtained. (Amended 09/99-07). **Ties shall be broken by the average of the number of dogs defeated using the first 3 qualifying runs under 3 different judges to obtain the title**

**04/11-05 Motion to Amend SR 01/99-03, as follows:**

**01/99-03. Herding Dog of The Year(HDOTY). What is added is the order in which the two components are taken to calculate scores.**

Beginning with Trials after January 1, 1999, a "Herding Dog of the Year" award will be given to the first ranked Bearded Collie in the Started, Intermediate, and Advanced levels of the AKC Herding Trial program each year in accordance with the then current AKC Herding Regulations. The ranking of each dog at each level will be calculated as follows. **First, identify the three highest point counts; then take the scores associated with the highest point counts.** Remainder of SR unchanged.

**04/11-06 Motion to Amend SR 12/01-02, as follows:**

**12/01-02. Fee for Herding Instinct Test. Specific fee amounts are deleted to avoid the need for future amendment. The instinct test sponsor can now mail both fees at one time rather than separately, and mailing is to the HIC stats secretary rather than the herding committee chair.**

**Effective July 2011 see HIC documents on the herding section of BCCA website for the fees**  
January 1, 2002, the fees charged for HICs are as follows:

~~Application Fee - \$15 per event~~  
~~Certificate Fee - \$3 per dog~~

**The application fee and certificate fees may be mailed together to the HIC secretary after the test is completed.**

**04/11-07 Motion to Amend SR 10/01-02, as follows:**

**10/01-02. Alternate Qualifications for HIC. Changes include adding a leg of the AHBA Instinct test as a qualifier for the HIC and reaffirming that it is the owner's responsibility to submit the necessary paperwork. The previous pedigree requirement is replaced by a copy of the registration certificate. The paperwork is submitted to the HIC secretary rather than the herding committee chair. A sentence has been added to state that these alternate qualifications for HIC are credited to the parent dogs only if the owner submits the proper paper work.**

The BCCA will accept **the following** as qualification for the BCCA Herding Instinct Certified (HIC).

- **One qualifying leg** of the AKC or AHBA Instinct Test Certificate
- **One qualifying leg** in any Test or Trial level in any herding venue which issues titles

**To receive the BCCA Herding Instinct Certificate for the qualifying legs listed above, the owner must supply a copy of the title certificate or score sheet, the appropriate fee, and a copy of the dog's registration certificate to the HIC secretary.**

**Parent dogs will receive credit toward the ROMI or ROMIX for progeny who attain the legs described above only if the owner submits the necessary information.**

**04/11-08 Motion to amend SR 07/84-02, as follows:**

**07/84-02. ROMI(X). The addition reiterates how a BCCA HIC is obtained and that a progeny contributes only once to the parents' awards regardless of how many herding titles the progeny has.**

An honorary award and title of "Register of Merit for Instinct" (ROMI) shall be given to any sire that has produced ten (10) herding instinct certified or AKC Herding Titled get and to any dam that has produced five (5) herding instinct certified or AKC Herding Titled offspring. A "Register of Merit for Instinct Excellent" (ROMIX) shall be given to any sire that has produced twenty (20) herding instinct certified or AKC Herding Titled get and to any dam that has produced ten (10) herding instinct certified or AKC Herding Titled offspring. Records of sires and dams shall be obtained by the Herding Committee from applications for the BCCA HIC title and from the AKC Awards publication. ROMI and ROMIX certificates shall be awarded at the BCCA National Specialty Awards Banquet. (Amended 7/7/90, 12/91-08, 05/95-02 and 04/99-03). **Credits are given for the BCCA HIC, whether achieved by an actual BCCA instinct test or by alternate qualifications as specified in SR 10/01-02 (amended 2011). A progeny may contribute only once towards the sire or dam ROMI or ROMIX award. .**

04/11-09 Motion amend Standing Rule October 1, 2007 ABM-03.

The current SR reads:

October 1, 2007 ABM-03. Reimbursement for the reasonable and customary expenses of travel for the AKC delegate to the four quarterly delegate meetings is approved.

The amended SR would read:

**October 1, 2007 ABM-03. Reimbursement for the reasonable and customary expenses of travel for the AKC delegate to the four quarterly delegates meetings shall be limited to coach airfare and two nights' lodging. (Amended 04/11-09.) (Freeman, for the current delegate, Kathy Coxwell.)**

Motions to be Considered in June

06/11-00 Motion to approve the minutes of the May, 2011 Board meeting. (Freeman)

05/11-01 Motion to require the BCCA Board to develop an annual plan effective July 1, 2011 and in perpetuity that includes yearly organizational goals, an action plan to accomplish these goals, and a projected budget for the year with input solicited from committee chairs, regional clubs, and the membership-at-large. This plan will be published and feedback solicited from the membership. It will be revised, if necessary, and approved at the annual membership meeting. In addition, the Board president will provide a written report to the membership of the club in February and June of each year on progress meeting these goals. (C. Serrine)

*Discussion: An annual plan with input from all stakeholders in the club, i.e. members-at-large, Board members, committee chairs, and regional clubs, while time consuming helps to set an invitational and inclusive tone for the year, communicates a sense of community, and*



*provides a framework from which the Board can plan its time and do the work that will move the club forward on behalf of the membership. All successful organizations realize that a system without a plan in place is driven by personal agendas or the issue of the day and cannot grow and thrive.*
