

BCCA Board of Directors Monthly Meeting

April 23, 2013

Proposed motion for May vote.

Motion to amend SR 03/91-02 to read as follows:

Mailing of Dues Notices.

Dues notices for the following year are mailed in May and are payable by July 1. New members approved during the last quarter of the previous year (i.e. April through June) will not have to pay dues for the following year. The following statement is to appear on the Membership Application: "Applicants' names will be published in the Newsletter. Applicants will be voted on at the next Board meeting following publication of names." (Amended 05/97-06).

The proposed change in the Standing Rule is to delete the requirement that new members approved in the last quarter of the previous year pay dues of \$7 for US and Canadian individual and joint memberships and \$10 for Overseas individual and joint memberships to cover publication postage for the quarter. Since the newsletter is now sent by email, there is no need to charge for postage.(Hayes)
