INSTRUCTIONS FOR VOTING

(Read and Follow Carefully)

1. This email or letter contains one ballot.
2. For a single membership print one ballot, for joint membership, print two ballots.
3. In each category (Regular and Sweepstakes) place an **X** (or ✓) on the line beside the nominee of your choice. Vote for only **ONE** person in the Regular category and **ONE** in Sweepstakes. Do not write anywhere else on the ballot. Any ballot containing more than the requested **X** (or ✓) per category will be disqualified.
4. Place each ballot in its own small blank envelope provided by you. Seal the blank envelope(s) after enclosing the ballot. Do not write on the blank envelope(s). *Any blank envelope containing more than one ballot will be disqualified.*
5. Address a separate envelope provided by you, to the Treasurer and mark it **INDIVIDUAL** or **JOINT BALLOT**. The Treasurer is

Place the blank envelope(s) inside the envelope addressed to the Treasurer and seal. Write your **NAME(S) AND RETURN ADDRESS** on the outer envelope and mail. If there is no name and return address, your membership cannot be confirmed and your ballots(s) will be disqualified.

6. To be valid, ballots must be received by the Treasurer at the address above **POSTMARKED** no later than **MARCH 30, 2026**.
7. *Failure to comply with the above instructions will disqualify your ballot.*
