#### **BUSINESS ADVISOR/TREASURER**

The BCCA continues to be fiscally sound with the exceptional BCCA Board as administrators of the operations of the club.

The BCCA's investment portfolio continues to have positive gains, yields improved dramatical this fiscal year allowing better returns on our investment portfolio. Interest alone this past year was over \$22,000, something the BCCA hasn't seen in several years. I am currently moving available cash to the CDs to get better returns for the BCCA assets. Maintaining and protecting the BCCA's investments even with average returns should be the priority. These are the memberships' assets that the BCCA has accumulated for the longevity of the BCCA. The BCCA is fiscally sound and there is always a need to have an emergency fund for unseen circumstances. The assets that the BCCA has should cover any unforeseen expenditures that would arise.

The BCCA was able to donate once again to the Charitable Trust and to AKC Reunite Disaster Fund totaling \$30,000. While expenses continually increase for the club, our Board is being fiscally sound in the operation of the club.

The 2024-2025 Budget was completed and approved by the BCCA Board of Directors at the July meeting. As always, the Budget is a guide and at times some expenditures may skew the proposed budget, but I feel this will provide a good direction for the upcoming year.

The BCCA's taxes were completed in August by a "third party" per the guidelines of the club. This allows another set of eyes apart from the review committee to oversee the accounting and correct any errors should they be found.
