This issue of the Newsletter inaugurates an experiment in a new means of communication between the Board of Directors and BCCA members. It is an outgrowth of our practice of sending copies of minutes of Board meetings to local Beardie clubs. The Newsletter should prove more effective since it will go to all members, thus reaching people who are not members of local clubs and those who may be absent from meetings where the minutes would be discussed. Our objective is to keep the BCCA membership fully informed on Board of Directors activities and doing this in a timely fashion.

As has been explained before, the Board of Directors conducts all of its business in monthly meetings by mail. Members of the Board submit motions which the Recording Secretary distributes monthly for voting. The results of these actions will be published in this Newsletter. The proposer of each motion and the way in which each member of the Board voted will also be shown. Note that any member may postpone a vote for a month on a specific motion if he wishes to contact the other members in support of or in opposition to it. Also note that we will give only the results of the voting on motions on individuals (membership applications, committee appointments, etc.) as if the vote was by secret ballot.

We plan also to include notices of interest to Club members, reports of committees, the results of Beardie classes in point shows (copied from the AKC Gazette) and a breeders list. Each entry in the latter will consist of the name of the breeder, kennel name (if any), address, phone number and whether the breeder normally offers puppies, grown dogs and/or stud service. There will be no charge for this service; however, the breeder must be a member of the BCCA. Just send your listing to the Editor.

Note that this Newsletter will not contain articles, letters, advertising or pictures. These will continue to be the domain of the Beardie Bulletin under the very competent editorship of Virginia Parsons. As a matter of fact, she has been asked to make a study of ways to improve the quality of reproduction of that periodical to more nearly match its importance to the BCCA membership. Look for future innovations here too.

One last word, the Board of Directors voted to try this Newsletter through June as an experiment. We solicity your comments and suggestions.

Report of the Executive Committee:

The Executive Committee dissolved the Show Committee due to the resignation of its chair-person and in order to expedite the assignment of forth-coming BCCA match shows. We thank the Chairperson, Bob Lachman, for any work he may have done and the two other members, Woody Ayers and John Lang, for their offer to handle the details of B matches in their respective areas. Since a report with recommendations has not been received by the Board of Directors from the committee chairman, and since time is getting short, the Executive Committee made the following assignments:

- The Tri-State Bearded Collie Club to form a show committee for the second BCCA qualifying AKC sanctioned B match to be held in that area in April or May, 1977.
- 2. The Queen City Bearded Collie Club to form a show committee for the third BCCA qualifying AKC sanctioned B match to be held in that area in late summer, 1977.
- 3. The New England Bearded Collie Club to host the 1977 annual BCCA meeting and the Eighth Annual BCCA Specialty with help as required from members of the Bearded Collie Club of Greater New York.

The Executive Committee disbanded the Membership Committee since its chairperson is no longer a BCCA member. It has assigned the other two members, Mimi Patrick and Emily Holden, to a Membership Subcommittee of the Constitution Committee to recommend to that Committee changes in requirements for membership in the BCCA By-Laws. They should study what other national breed clubs require of their applicants and should solicit suggestions from the BCCA membership.

Report of the Constitution Committee - Tom Small, Chm, Tom Davies, Ian Morrison

The Consitution Committee has assigned parts of the BCCA Constitution and By-Laws to each of its members for the purpose of analyzing each sections for desirable changes. It has tentatively decided to recommend the following changes and solicits comments from the BCCA members:

- 1. Change the term of office for Officers and Directors to two years with the President, Recording Secretary and three Directors elected one year and the Vice-President, Corresponding Secretary, Treasurer and two directors elected the next.
- 2. Provide for opening the ballots in the annual election two weeks before the annual meeting so that nominees can better decide whether or not to travel to the meeting.
- 3. Provide for holding the annual meeting and specialty during the period from mid-June through mid-July instead of requiring them to be in June as at present.

The Committee will also solicit suggestions for other changes to the Constitution and By-Laws from the BCCA membership.

Report of the Committee on the Standard - Moira Morrison, Chp, Tom Davies and Joan Surber.

The Committee on the Standard sponsored a workshop for judges of working breeds on Sunday, February 13, 1977. Feedback from the judges and from the AKC has indicated that the exercise was most successful. After a showing of some slides and movies on Beardies the workshop examined the current Standard paragraph by paragraph. The judges in the audience led by Haworth Hoch and Lynette Saltzman asked questions of a panel of breeders consisting of Tom Davies, Ann Dolan and Moira Morrison. The objective was to clarify terms and phrases which the judges found ambiguous. The point was made several times that the breeders' comments in no way replaced the Standard which has been approved by both the BCCA membership and the AKC Board of Directors. A second purpose for this exercise was to obtain input from the judges for the work of the Committee in preparing a draft of a revised standard. The Committee was encouraged by both the judges and AKC officials to repeat the workshop, perhaps in other parts of the country.

The Committee has received many comments and suggestions from several local breed clubs and from numerous individuals. It has also obtained a copy of the proposed new Standard in Britain. It plans to solicit comments for another month or so and then to start drafting a new proposed Standard which in turn will be submitted to the BCCA membership for comments.

We want to get many Club members busy and to report on their effectiveness. A sign of a maturing Club is that its Officers and Directors have earned a reputation serving the Club. We are not there yet, but this should be a good start in that direction.
