07/12-00 Motion to approve the minutes of the July 21, 2012 meeting. (Taylor)

08/12-01 Motion to amend SR 08/11-04 as follows: Motion to approve the Executive Committee's decision to establish the following official guidelines for the Bearded Collie Club of America ("BCCA") Board of Directors Yahoo E-Mail List ("E-Mail List"), founded on April 7, 2004:

The E-Mail List is a private e-mail list owned by, and operated under the auspices of, the BCCA for

members of the Board of Directors of the BCCA to discuss official BCCA matters.

The archives of the E-Mail List are considered official records of the BCCA and, as such, shall be maintained by the Recording Secretary *an officer* of the BCCA who shall be, in name only, the "owner" and "moderator" of said E-Mail List during their term of office.

"Ownership" and "moderator" status of the E-Mail List shall be relinquished to a newly-elected BCCA Recording Secretary officer by the current BCCA Recording Secretary officer holding said position by midnight on the last day of their term of office (i.e., June 30).

No member(s) of the BCCA Board of Directors may invoke ownership of the E-Mail List by virtue of their temporary "ownership" or "moderator" status of said E-Mail List.

It is expressly understood that topics discussed on the E-Mail List are confidential in nature and members of the Board of Directors agree not to forward the contents of such messages, either in writing or verbally, to any person or organization not on the E-Mail List without permission.

No cross-posting to other e-mail groups is allowed nor is addressing this group when sending to other e-mail lists. This E-Mail List is for BCCA Board Members only.

Newly-elected BCCA Board Members shall be added to the E-Mail List one (1) month prior to taking office; out-going BCCA Board Members shall be removed from the E-Mail List immediately upon the expiration of their term of office.

**08/12-02** Motion to amend SR 09/11-06 as follows: Motion to open the BCCA Members List with the following rules:

No brags or disparaging comments about any dogs allowed.

No ads allowed.

No attachments will be permitted.

No complaints about other members/persons tolerated.

No discussions of other dog clubs or registries except as they may relate to any relationship existing or proposed with the BCCA.

No personal attacks or discussions allowed on other members or their views. If you have a problem with a fellow BCCA member, please discuss it with them PRIVATELY.

Members are NOT allowed to forward posts from other members or non-members on any subject. Only original posts from the sender are acceptable. List members who break this rule will immediately be placed on moderated status.

In order to subscribe to the list, each person must be a current member of the BCCA and the e-mail address used to subscribe to the list must match the one currently on file with the club. E-mail addresses that cannot be confirmed will result in a subscription to the list being denied.

The Members List is a fully moderated list and owned by the Bearded Collie Club of America. The Members List shall be maintained by an officer of the BCCA Board of Directors who shall be, in name only, the "owner" and "moderator" of said Members List during their term of office. "Ownership" and "moderator" status of the Members List shall be relinquished to a newly-elected BCCA officer by the current BCCA officer holding said position by midnight on the last day of their term of office (i.e., June 30).

Its existence is for the sole purpose of discussing current club business, the exchange of ideas and offering positive suggestions by the BCCA membership. Those who choose to ignore the rules above will be given a ONE TIME warning. Should the undesirable posting behavior be repeated, the offender will be placed on a NO POST status for a minimum of one week. During this time, he/she can read mail, but cannot send to the list. A third offense will result in the permanent removal from the list by the moderator or List Owner. (Alspaugh)

- 09/08-01. Eukanuba Medallions and Ad Funding.

Funds are approved in perpetuity to sponsor medallions for BCCA members who are the winners/top scorers in conformation, obedience/rally, agility, and other events that may be offered at the Eukanuba National Championship, as well as to place a BCCA Club ad in the Eukanuba Commemorative Catalog.

09/12-01 Motion to approve "The Avery Dudasch Award" as follows:

"The Avery Award" honors the memory of 11 year old Avery Dudasch, who showed great courage, hope, and faith in her battle with cancer. A certificate will be presented annually at the BCCA National Specialty Awards Banquet to any Bearded Collie and his/her handler, who have performed pet therapy visiting ill children (at a hospital setting) during the previous calendar year. To be eligible, the dog must be certified through a therapy organization that requires certification and carries liability insurance (e.g. Delta Society/Pet Partners, Therapy Dogs International, Therapy Dogs, Inc.) and the handler must be a BCCA member in good standing. Additional eligibility requirements can be found under Standing Rule 07/08-03. The BCCA Therapy Committee will be responsible for verifying recipients of this award each year. (Schroeder)

09/12-02 Motion to approve "The Casey – The Wonder Dog - Award" as follows:

The BCCA will recognize any physically challenged OR rescue Bearded Collie doing therapy work by issuing a "Casey" at the National Specialty Awards Banquet. This award is in memory of Casey, who overcame his early life in a puppy mill and an injury which cost him a leg, to become a much beloved therapy dog to thousands of people. To be eligible, dogs must have some sort of physical challenge (e.g. missing a limb, deaf, blind) OR be a

rescue Beardie. In addition, the dog must be certified through a therapy organization that requires certification and carries liability insurance (e.g. Delta Society/Pet Partners, Therapy Dogs International, Therapy Dogs, Inc.) and the handler must be a BCCA member in good standing. This certificate will be given to the same dog only once. (Schroeder)
